5. Terms of payment

A deposit of 50% is required upon application. Applicants should remit the appropriate amount directly to the organizer. Final balance payment of 50% is due on or before 30 May 2025. All bank charges are to be borne by applicant.

6. Cancellation

If an applicant withdraws his application for whatever reason, before he receives either a rejection or confirmation of his application, any participation fee paid will be forfeited.

If the exhibitor notifies the organiser of his withdrawal within three months of the start date of the event, he is liable for the total participation fee.

Should the exhibitor under contract (i.e. in receipt of confirmation) inform the organiser that he will not be participating at the event, providing

the organiser is able to resell the stand without loss, the payment to be made by the exhibitor will be reduced to a handling fee of RMB7,000 irrespective of the exhibitor's full liability for additional costs, visitor guide fees, etc.

7. General terms and conditions of the event
